PERINTAH KASTAM (DUTI ANTI-LAMBAKAN) (NO. 2) 2021 (PINDAAN) 2025

PADA menjalankan kuasa yang diberikan oleh seksyen 25 Akta Duti Timbal Balas dan Anti-Lambakan 1993 [*Akta 504*] dan subseksyen 11(1) Akta Kastam 1967 [*Akta 235*], Menteri membuat perintah yang berikut:

**Nama dan permulaan kuat kuasa**

1. (1) Perintah ini bolehlah dinamakan **Perintah Kastam (Duti Anti-Lambakan) (No. 2) 2021 (Pindaan) 2025**.

(2) Perintah ini berkuat kuasa bagi tempoh mulai 5 Februari 2025 hingga 24 Disember 2026.

**Pindaan Jadual**

2. Perintah Kastam (Duti Anti-Lambakan) (No. 2) 2021 [*P.U. (A) 469/2021*] dipinda dalam Jadual, dalam ruang (5)—

(a) dengan menggantikan perkataan “9.47%” dengan perkataan “9.07%”; dan

(b) dengan menggantikan perkataan “2.09%” dengan perkataan “3.12%”.

COUNTERVAILING AND ANTI-DUMPING DUTIES ACT 1993 AND CUSTOMS ACT 1967  
CUSTOMS (ANTI-DUMPING DUTIES) (NO. 2) ORDER 2021 (AMENDMENT) ORDER 2025

IN exercise of the powers conferred by section 25 of the Countervailing and Anti-Dumping Duties Act 1993 [*Act 504*] and subsection 11(1) of the Customs Act 1967 [*Act 235*], the Minister makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **Customs (Anti-Dumping Duties) (No. 2) Order 2021 (Amendment) Order 2025**.

(2) This Order has effect for the period from 5 February 2025 to 24 December 2026.

**Amendment of Schedule**

2. The Customs (Anti-Dumping Duties) (No. 2) Order 2021 [*P.U. (A) 469/2021*] is amended in the Schedule, in column (5)—

(a) by substituting for the words “9.47%” the words “9.07%”; and

(b) by substituting for the words “2.09%” the words “3.12%”.
