PERINTAH KASTAM (DUTI ANTI-LAMBAKAN) (KAJIAN SEMULA DIPERCEPAT) 2025

PADA menjalankan kuasa yang diberikan oleh subseksyen 11(1) Akta Kastam 1967 [Akta 235] dibaca bersama-sama subseksyen 28B(1) Akta Duti Timbal Balas dan Anti-Lambakan 1993 [Akta 504], Menteri membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Kastam (Duti Anti-Lambakan) (Kajian Semula Dipercepat) 2025**.

(2) Perintah ini mula berkuat kuasa pada 22 Februari 2025.

Tempoh kajian semula dipercepat

2. Pengenaan duti anti-lambakan di bawah Perintah Kastam (Duti Anti-Lambakan) (Kajian Semula Pentadbiran) (No. 2) 2021 [P.U. (A) 312/2021] tidak dikenakan kepada Tay Nam Steel Manufacturing & Trading Co., Ltd., pengeksport gegelung keluli yang dipracat, dicat atau disalut warna dari Republik Sosialis Viet Nam semasa kajian semula dipercepat sedang dijalankan mulai 22 Februari 2025 hingga 20 Ogos 2025.

COUNTERVAILING AND ANTI-DUMPING DUTIES ACT 1993

CUSTOMS (ANTI-DUMPING DUTIES) (EXPEDITED REVIEW) ORDER 2025

IN exercise of the powers conferred by subsection 11(1) of the Customs Act 1967 [Act 235] read together with subsection 28B(1) of the Countervailing and Anti-Dumping Duties Act 1993 [Act 504], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Customs (Anti-Dumping Duties) (Expedited Review) Order 2025**.

(2) This Order comes into operation on 22 February 2025.

Period of expedited review

2. The anti-dumping duties imposed under the Customs (Anti-Dumping Duties) (Administrative Review) (No. 2) Order 2021 [P.U. (A) 312/2021] shall not be imposed on Tay Nam Steel Manufacturing & Trading Co., Ltd., the exporter of prepainted, painted or colour coated steel coils from the Socialist Republic of Viet Nam while the expedited review is being carried out from 22 February 2025 to 20 August 2025.
