COUNTERVAILING AND ANTI-DUMPING DUTIES ACT 1993

NOTICE OF TERMINATION OF ANTI-DUMPING DUTY INVESTIGATION WITH REGARD
TO IMPORTS OF STEEL WIRE RODS ORIGINATING OR EXPORTED FROM
THE PEOPLE'S REPUBLIC OF CHINA, THE REPUBLIC OF INDONESIA
AND THE SOCIALIST REPUBLIC OF VIET NAM

IN exercise of the powers given by paragraph 26(1)(a) and subsection 26(2) of the Countervailing and Anti-Dumping Duties Act 1993 [Act 504], the Government terminates the anti-dumping duty investigation with regard to the imports of steel wire rods classified under the Harmonised System Code ("H.S. Code") and ASEAN Harmonised Tariff Nomenclature ("AHTN") 7213.91.10 00, 7213.91.20 00, 7213.91.90 00 and 7227.90.90 00 originating or exported from the People's Republic of China, the Republic of Indonesia and the Socialist Republic of Viet Nam by reason of the withdrawal of the petition by the petitioner, with immediate effect.
